Concerning the remuneration: As the project was commissioned by a German broadcaster we are generally able to use a big amount of songs via their blanket agreement - but only inside Germany. That's why there is no actual budget for music licensing/international usage. However, we think that the series will be as thrilling to watch for an international audience.

What we can offer for the use of your song is a total of $\notin 600$.

This would need to include the right to use the work (composition, lyrics) and recording in all media (excluding theatrical release), worldwide and in perpetuity.

We know that this amount is a far cry from the usual fees. But we hope that reading about the project will warm your heart. We would be eternally grateful for your support of this passionate, unique project.

Dear [REDACTED],

Thank you for confirming the [REDACTED] registration of the series. However, this registration does not negate the unauthorized use of my composition. As you're aware, the ongoing broadcast of my work on [REDACTED] constitutes infringement under §2 UrhG, as no formal contract was ever finalized. Additionally, your company has expanded the granted rights beyond our initial discussions, including promotional usage, trailers, and subtitles—none of which were included in our soft terms or granted in any written agreement.

To resolve this efficiently, I propose the following terms:

- •€50,000 as an immediate good-faith payment to halt further unauthorized distribution.
- •€250,000 within 7 days, inclusive of a 15% discount for mutual NDA execution.

•€300,000 if unpaid after 7 days.

•€1,000 per day in compensation for ongoing damages under §97 UrhG, accruing after 14 days due to continued broadcasts.

Legal basis for compensation:

1.The hypothetical license fee [REDACTED] would pay for broadcasting my work, based on [REDACTED]'s published rates for comparable compositions.

2.The expanded commercial exploitation of my composition beyond the originally discussed scope.

I am also contacting my [REDACTED] representative today to address [REDACTED]'s handling of this matter. I hope we can resolve this amicably. However, without confirmation of payment by 5:00 PM CET tomorrow, I will be compelled to escalate the matter through [REDACTED], [REDACTED], and legal channels.
